STYLE and SUBSTANCE

The first time I ever saw Sharon Wolfe-Cranston, it was threatening rain. I was holding a clipboard to register any last minute contestants who would brave uncertain weather to surf in the 2005 Waterman's Challenge. There weren't many takers. Behind my shoulder I overheard someone say, "Sharon Wolfe-Cranston is here," and the way they said it – first name and two last names – made me turn my head. They were looking to their right, where Minutemen butts the beach, toward a group of people watching the waves build, and the sky build. I knew all of them save one.

She stood with her hands on her hips, pointing now and then. She seemed intent on the waves, while people around her looked up, wondering whether a rain delay was inevitable. Someone shouted, "Where's

Sean?" and someone answered, "Is that his van leaving?" By this time, I had decided the woman with the wavy blonde hair was the object of the overheard comment. She seemed unfazed by the frenetic weather speculation, only looking up, finally, when it started to rain.

The sky cleared just enough for the contest to proceed, and by the end of the two-day challenge, Sharon-with-two-last-names had surfed to a win in the Women's Masters' Shortboard.

I did not meet Sharon formally until a couple of years later, and it took another three years after that

before I understood whom I had met. But I understand now, and so do a lot more people, thanks to Sharon's induction into the East Coast Surfing Hall of Fame. On January 15, Sharon joined the select group of East Coast legends, along with 2010 inductees Bud Gardner, Bob Rohmann, Jeff Klugel, Scott McCranels, Sue Lloyd Hogan, Doug Waters, Ross Houston, and George Miller.

With four U.S. surfing championships, spanning 12



years - in four different divisions - on three coasts, it's an honor overdue and well deserved. Sharon's first championship came in the Girl's Division at Padre Island, Texas, in 1979. She followed that up with championships at Trestles and Oceanside in 1981, Cape Hatteras in 1982, and Sebastian Inlet in 1990, with two East Coast titles in 1981 and 1982.

But for all the recognition it has brought her, that is not the whole story. Sharon has made her place not only in surfing history, but also in the lives of many in Cocoa Beach. She works in the youth department

When Sharon's mother was stricken with cancer in 1982, Sharon chose to stay with her instead of pursuing the contest circuit or a professional career in surfing. "She was always there for me and I felt I couldn't continue on or do contests without her being there and I needed to take care of her," Sharon said at her induction ceremony. That is the kind of commitment that Sharon has shown in her life since, to her father and to Jeff and their daughter, Torrey, to her library children and Girl Scouts, and to her community. She volunteers for the surf museum and is the driving force behind the museum's surf lecture series at the library.

I know, you thought she was just the woman who makes the popcorn, and that's the way she would prefer it. Nothing flashy. Stylish in the water, plenty of substance. A champion, by any measure. ■

Paddle On

Miami native Cynthia Aguilar has entered almost all of the paddleboard events that benefit CBSM. Her first charity event was the Kommona Paddle, in 2009, in which John and Marie Hughes paddled. Cynthia's next distance event is a solo paddle from Cuba to Key West.

Cynthia Aguilar was born and raised in Miami and for the past eight years has been an Ocean Lifeguard for the City of Miami. "I was born to be a lifeguard, it's in my blood. While working for the Beach Patrol, my Supervisor, Hank Oppenborn, introduced me to the sport of paddleboarding and I found my new passion and love in life," Aguilar said.

To raise money for Care Resources/AIDS Walk, Cynthia put together The Bimini Challenge. On April 29, 2007, with only a 15-foot Boston Whaler support boat and a crew of three friends, she decided it was now or never. "We put our lives at risk, crossing the Bermuda Triangle and Gulfstream for this amazing journey," she said. It took her 19 hours, 33 minutes, to make 58-mile crossing between Bimini Cat Cay Island in the Bahamas and Dania Beach.

Cynthia seeks to make a difference in people's lives through her paddling. She seeks to bring awareness and funds to important causes while bringing together people from different water sports.

Kommona Paddle was the first event held under her non-profit organization, Paddle On. It raised over \$1,000 for Care Resources/Aids Walk. Forty-two paddlers signed up for the three- or five-mile paddle course around the Venetian Islands, Miami. The next Kommona Paddle will be April 10 and will also benefit Care Resources/Aids Walk. The start will be at Purdy Docks in Miami Beach, with a paddle around the Venetian Islands.

Cynthia is training for her next solo paddle to benefit Make-A-Wish Foundation. In September 2010 she will paddle from Marina Hemingway, Cuba, to Key West. It will take 25-30 hours to paddle the approximately 100 miles.
